- 1.0 Sealed Tenders for CNC TURNING MACHINES(2 NOS) as per specifications given in the attached Schedule (Part III) are invited by the General Manager, Central Tool Room & Training Centre, Bonhooghly Industrial Area, Kolkata-700 001 (hereinafter called "the Centre and/or the Purchaser"). The tenders shall be received up to 12.30 hours on 29/12/2009 and shall be opened, in the presence of intending tenderers as per schedule and procedure described in the tender documents. Tenders received late will not be accepted. Tenders should be accompanied by interest free Earnest Money as specified in Part-IV (Special Conditions) for each tender in the form of Demand Draft in favour of "Central Tool Room & Training Centre, Kolkata" payable at Kolkata. **Tenders without Earnest Money will not be accepted. Earnest Money should be kept along with the Technical bid envelope-PART-A. Earnest Money will be returned to unsuccessful bidders on finalization of Tender process.** Tenderers registered with DGS&D and /or NSIC for machine/equipment/goods mentioned in Part-III are exempted from depositing Earnest Money and Security Deposit on **submission of proof of current valid registration (as on date)** along with Part "A" of the tender.
